

AN ALMOST SURE LIMIT THEOREM FOR THE MAXIMA AND SUMS OF
STATIONARY GAUSSIAN SEQUENCES

Abstract: Let X_1, X_2, \dots be some standardized stationary Gaussian process and let us put:

$$M_k = \max(X_1, \dots, X_k), \quad S_k = \sum_{i=1}^k X_i, \quad \sigma_k = \sqrt{\text{Var}(S_k)}.$$

Our purpose is to prove an almost sure central limit theorem for the sequence $(M_k, S_k/\sigma_k)$ under suitable normalization of M_k . The investigations presented in this paper extend the recent research of Csaki and Gonchigdzan [1] and Dudziński [2].
